General comments and recommendations for future work	This is the fastest growing specialization of interpreting and therefore should remain as a committee, as its work will be ongoing. Many FIT associations continue to focus on translation and most interpreting is reigned by AIIC as conference interpreting is considered the only professional level interpreting in several countries. Medical interpreting is a service that is direly needed in many countries, not only the developed countries, and due to lack of standards or involvement from the translation associations, ad hoc individuals are being hired to do the job. It is imperative that we engage FIT associations to engage themselves with their healthcare systems to inform them of the level of professionalism needed to interpret in any specialized settings such as the legal or medical one.

**Note:** This committee has struggled, as the previous chair had not set up monthly meetings, so months would go by with no activity, which I reported when I was an observer. Then the chairperson resigned with no process of replacement, even though according to the committee.
