Location of the stand

Access to Internet

Congress exhibitors and participants have free Internet access throughout the entire Hotel Meliá International Convention Centre. Therefore, they may make presentations online.

Electrical connections

Each stand has an electrical connection (110 - 240 V AC). Due to differences in global electrical outlets, we ask you to bring adapters that are compatible with outlets used in most countries in the Americas.



Lighting conditions

The exhibition areas are bright with natural light through the glass facades, although a combination of natural and artificial light will be available.

Catering

Cleanliness of the stand

When the exhibition has been set up, and during the Congress, only the hallways will be cleaned. Please, dispose of your packaging yourself. Stand materials that remain in hallways after setup time will be eliminated by the organizers, and the exhibitor in question will have to pay for that service.

TERMS & CONDITIONS

- 1. By returning this signed Trade Show Agreement ("Agreement"), you agree to be a Exhibitor at the XXII FIT World Congress organised by the FIT and ACTI ("the Organisers") on the terms and conditions set out below and as attached to this Agreement.
- 2. Upon receipt of your signed agreement together with payment, acknowledgment of receipt will be sent in writing.
- 3. The exhibition areas will be guarded outside the Congress hours by the host hotel's security personnel. However, during exhibition hours, you will be responsible for the safekeeping of your equipment and materials. The organizers will not assume responsibility for exhibitors' property.
- 4. Yor Exhibitor rigths will not commence until a signed agreement and full payment has been received.
- 5. It is prohibited to paste materials onto walls, doors or glass surfaces, or to cover or coat the floor in materials that can cause damage when removed. Anyone who causes such damage may be fined.
- 6. The exhibition areas will be guarded outside the Congress hours by the host hotel's security personnel. However, during exhibition hours, you will be responsible for the safekeeping of your equipment and materials. The organizers will not assume responsibility for exhibitors' property

- 7. You agree to pay FIT/ACTI the full amount payable. Monies paid are non-refundable.
